- *Barrow v. Willis, et al.*, 1st Circuit No. 17-1819 (affirming grant of motion to dismiss claims against defendant attorney based on the Fair Housing Act and 42 USC §§ 1981, 1982 and 1983)
- *Linardon v. Birmingham Anadu*, Suffolk Super. Ct. C.A. No. 1684CV00604 (obtained summary judgment in favor of attorney defendant in claim based on an underlying eviction trial, judgment affirmed after rescript)
