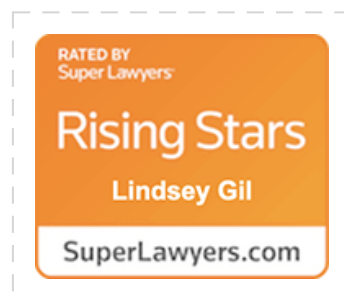
- Attendee, International Association of Defense Counsel (IADC) Trial Academy in 2015.
